REAL PROPERTY:

SUMMER TAXES are payable to the City of Trenton Treasurer thru August 31, 2023 without penalty. Beginning September 1, 2023, a 4% penalty will be added. ***Beginning March 1, 2024, taxes are delinquent and must be paid to: Wayne County Treasurer, 400 Monroe-5th Floor Detroit, MI 48226-2942 (313)224-5990 or at www.treasurer.waynecounty.com***

WINTER TAXES are payable to the City of Trenton Treasurer thru February 14, 2024 without penalty. Beginning February 15, 2024, a 4% penalty will be added. ***Beginning March 1, 2024, taxes are delinquent and must be paid to: Wayne County Treasurer, 400 Monroe-5th Floor Detroit, MI 48226-2942 (313)224-5990 or at www.treasurer.waynecounty.com***

PERSONAL PROPERTY:

Same as Real Property except that an additional penalty of 1% per month will be applied beginning March 1, 2024.

Delinquent Personal Property Tax bills are payable only at the City of Trenton Treasurer's Office.

2023 PERSONAL PROPERTY TAXES are based on assessments as of **DECEMBER 31, 2022.**
